Scheme of Regulation :

1. Back ground:

- a. Power Grid Corporation of India Ltd (POWERGRID) had proposed Power Supply Regulation on STOA power w.e.f. 00:00 hrs. of 18.06.2020 from KSK Mahanadi Power Co. Ltd., a generating station located at Chhattisgarh, in Western Region. The Regulation notice(s) from POWERGRID has been received on 16.06.2020 & 03.06.2020, (as per the CERC Regulations) this will be implemented with effect from 00:00 hours of 18.06.2020 in accordance with this implementation plan.
- b. POWERGRID has submitted through an affidavit to indemnify, defend and save the SLDC, RLDCs harmless from any and all damages, losses, claims and actions, demands, suits, recoveries, cost and expenses, court costs, attorney fees, and all other obligations arising out of or resulting from the regulation of power in terms of the regulations to its procurers listed at 1(a) above. This indemnification is in line with section 5 of the CERC (Regulation of Power Supply) Regulations and paragraph 13.9 of the Statement of Reasons for these regulations as per CERC Order dated 02.09.2015 in Petition No 142/MP/2012.

2. Regulation:

This regulation of STOA power- Collective (DAM & RTM) & Bilateral will be effected from 00:00 hrs. of 18.06.2020. The regulation shall continue till the time as stated at Table-1, under the field "Period of Regulation" or up to an earlier date if default is rectified which would be communicated by the regulating entity to WRLDC in line with the CERC Regulations. Under Regulation 25A of the Open Access Regulations, no STOA will be allowed from the date of commencement regulation of power supply as per CERC Order dated 02.09.2015 in Petition No 142/MP/2012.

Scheme:

- i) As per the existing procedure, WRLDC has been facilitating the scheduling of power from KSK Mahanadi under LTA & STOA.
- ii) No STOA will be granted to KSK under Regulation 25A of Open Access Regulations from the date of commencement regulation of power supply as per CERC Order dated 02.09.2015 in Petition No 142/MP/2012.
- iii) Accordingly, no STOA application with KSK Mahanadi as injecting entity will be processed & approved by RLDCs. KSK Mahanadi won't be allowed to bid over the power exchanges for scheduling collective transactions.
- iv) All SLDCs shall take note of this implementation plan and act accordingly.

3. Grid Security Aspect:

RLDCs/SLDCs would closely monitor the system parameters during the period of power supply regulation and would take prompt action to maintain the grid parameters within IEGC limits. In case of over-drawl by the defaulting entities, the SLDC would take prompt action to curtail the over-drawl for safe operation of the grid. All the entities including regulating and regulated ones, would take prompt action in respect of grid security and on instruction from RLDCs/SLDCs. WRLDC may defer this implementation plan for

regulation of power supply in case of any grid security related issue in line with Regulation 11(2) of the CERC (Regulation of Power Supply), Regulation, 2010.

4. Power Supply to essential services:

All RLDCs and SLDCs will ensure that power supply to sensitive/important installations like defense, mines, medical, water-supply, aviation, railways, installations of national importance etc. are not affected on account of this regulation. Further all SLDCs shall ensure that there is no impact on international agreements and other sovereign obligations.

5. Deferment / Withdrawal of regulation:

Regulating Entity proposing to withdraw / postpone the regulation, shall inform at least **two days** prior to the proposed day of withdrawal or postponement of such regulation as per the regulation 9 of CERC regulations.
