महोदय,

Ministry of Power (MOP) vide order dated 17<sup>th</sup> July 2019 had issued the procedure for Scheduling of Power to Distribution Company from inter-state generators in the event of non-availability of adequate payment security. Accordingly, POSOCO is maintaining Payment Security Administration (PSA) portal (<https://psa.posoco.in>) for all Inter State Generating Stations.

Subsequently, Ministry of Power (MOP) has issued a revised procedure vide order dated 28<sup>th</sup> August 2020 (enclosed) for scheduling of power to Distribution Company in the event of non-availability of adequate payment security for intra state generating stations(except state owned) in addition to inter-state generating stations.

Accordingly, POSOCO has incorporated necessary modification in PSA portal (<https://psa.posoco.in>) to facilitate intra-state generators (except state owned) to provide the status of payment security on daily basis.

Since the scheduling of intra-state generators is carried out by the SLDCs, the following activities are to be carried out by SLDCs in PSA portal:

- i. Onetime confirmation of the validity of contracts of the respective generators.
- ii. Provide the scheduling status of the intra-state generators based on the payment security status provided by the respective generators on daily basis.

Accordingly, access to this portal has been extended to SLDCs and they are requested to obtain the login credentials for PSA portal from NLDC (psa@posoco.in) for the username and password.

SLDCs are also requested to inform concerned intra-state generators to obtain the username and password from NLDC (psa@posoco.in) to access the PSA portal for the following activities:

- i. Provide contract details
- ii. Provide the payment security status of the valid contracts on daily basis
